**REUNION '08** – It seems the last 2 years have been “soft” and we are now competing with large corporations for rooms. We have also begun to have to plan around the Houston Rodeo Parade. Those of us working on the planning of the reunion are well aware that March 1, 2008 is on a Saturday. However, unless you have your heart set on a candle light ceremony, we have to go with a different weekend because the parade is on the 1<sup>st</sup> & the city will shut down the streets of downtown in the wee hours of Saturday morning until late afternoon. I negotiated with the Doubletree for Feb. 23<sup>rd</sup> to avoid room rates of \$168/night the weekend AFTER the 1<sup>st</sup> of March. Price negotiations started off rather rocky so I suggested we just might have to go to Motel 6 & order pizza delivered. We finally agreed to \$89/day and '07 meal rates. First, I had to send in a letter requesting permission for the 3 volley salute (noise ordinance), port-a-potty, putting chairs on the site, sound system, etc. Now Lin can proceed with her assignments arranging the Memorial Service & send in the formal request form.....

**FROM DOWN UNDER** – Peter Winstanley emailed greetings from Western Australia reporting their memorial service held March 3 in St. John's Anglican Church in Fremantle. With 6 survivors of the Perth living in Western Australia, 5 attended with their families. They were: Arthur Bancroft, Robbie Roberts, Digby Gray, Fred Skeels and Norm Fuller. I had to re-read the list of Perth survivors because my dad's nickname was Robbie. What are the odds that two men from two different countries from the opposite sides of the world fought in the same battle and endured the same horrors as POW had the same name? (Robbie Roberts) I learn something new and interesting every day! Gavin Campbell emailed of their memorial service on March 1 in Canberra at the Australian War Museum. The HMAS PERTH National Association organized the impressive service & wreaths laid at the tomb of the Unknown Soldier. The lament was piped followed by the Naval Ode, the Last Post, a minute's silence then the Reveille and closing prayer. My email friend, Di Elliott, (father wasn't on the PERTH but was a POW with the PERTH & HOUSTON men introduced herself to Capt. Dooris of the American Embassy. I will be in touch with him soon. The Australian Embassy focused on Australian War Brides as part of the commemoration for ANZAC Day. After asking Australian women who met and married US servicemen during or after WWII or the families of any such couples, there was a documentary shown on April 24th "For the Love of a Soldier" prior to a talk by researcher Ms. Robyn Arrowsmith. Later that day, a reception was hosted for the War Brides and families by Australia's Ambassador to the United States, Dennis Richardson. The Australian American Chamber of Commerce and TAZOT (The Australia-New Zealand Organization of Texas) co-hosted an ANZAC Day Ceremony & "sausage sizzle at the Bear Creek Park War Memorial on April 29<sup>th</sup>.

**NAVAL ORDER OF THE UNITED STATES NEWS** - Our very own CAPT. Carter. Conlin is the national Commander General of the NOUS. Their National Congress meeting was October '06 in Arlington, VA & was a huge success. **FROM ACROSS THE POND** – Ian Mort of Lincolnshire, England emailed to report his father was on the HMS Exeter in '42. This year there were 7 EXETER men along with 2 members of the ENCOUNTER's crew (which was the ship his father was on when it was sunk on March 1. Approximately 50 people attended the reunion in Devon. Ian sends his best wishes to the survivors & relatives of those who served on a most gallant and beautiful American heavy cruiser! I was contacted by Ron Taylor of England and Mary Michael (British born/living in California) who both have fathers that were POW's on the Death Railway. Unfortunately, we started out on the wrong foot as I thought they were a part of COFEPOW who have burned their bridges with us. After we got THAT cleared up, we were able to move forward. Their father's are known as FEPOW (Far East Prisoners of War) & consider ours the same. The Next Generation of FEPOW feel as we do that there is no recognition of these men by our governments or teachings. There is a movement that is spreading throughout to establish an official *Remembrance Day* of August 15 to include ALL Allied forces throughout the world. The date of August 15 is known here in the USA as VJ Day. The project is in its infancy however, the idea is well worth supporting. I had already made plans to contact my local paper prior to August 15<sup>th</sup> with a short editorial stating the bombing of Japan was a necessary evil & saved many of our family member's life. One and all need to take pause on that date to give thanks for the return of our men, remember those lost and be grateful that horrific war ended.

### **What Exactly is the Cruiser Houston Collection?**

Most *Blue Bonnet* readers are aware of the permanent exhibition honoring the USS *Houston* (CA-30) that is on display at the University of Houston's M.D. Anderson Library. What they may not realize is that the exhibition is only the tip of the iceberg when it comes to the library's USS *Houston* holdings. The vast majority of our *Houston*-related materials form the Cruiser Houston Collection, an archival collection which is used for research by patrons both in our reading room and around the world.

So just what is an archival collection? The term usually describes a group of related materials such as documents and photographs which have enduring historical value. Archival collections focus primarily on paper materials, rather than the kind of three-dimensional memorabilia collected by museums. These materials are typically housed in archives, which may be found in university libraries, public libraries, or other settings. Archival collections typically contain only one copy of any item for research purposes. Duplicate items are normally returned to the donor, given to another archives, or discarded.

The Cruiser Houston Collection is comprised of 48 linear feet of material, which includes 68 boxes, 9 scrapbooks, 10 oversize items, 28 framed items, and a model of the ship. Materials from the collection have been used by patrons for researching family members, writing articles for magazines like *America in WWII* and *The Houston Review of History and Culture*, for television programs including a British documentary on World War II in the Pacific produced by Carlton Television, and Jim Hornfischer's recent book *Ship of Ghosts: The Story of the USS Houston, FDR's Legendary Lost Cruiser, and the Epic Saga of Her Survivors*.

The Cruiser Houston Collection is housed in the library's Special Collections department. Any member of the general public may visit Special Collections and view items from the collection in our reading room. Because this collection is of great national and international interest, we also receive many queries via telephone, e-mail, and the Internet. As Special Collections librarians, we believe that providing this type of one-on-one service to patrons doing research with a collection is the most fundamental part of our mission.

The USS Houston Exhibition is a permanent exhibition, complete with professional signage and labels. As was the case with the earlier Brown Room permanent exhibition, there are no plans to rotate items or add new items to the display. The Cruiser Houston Collection is still accepting materials, but Special Collections strongly prefers significant runs of original letters, documents, diaries, or photographs from the period 1929-1945 to single items, contemporary materials, or scanned copies. We also plan to be more selective in the acceptance of memorabilia (medals, coins, stamps, etc.) now that the permanent exhibition has been completed.

From: Commander Task Group 5.3.  
To: Commander Task Force 5.

Subject: Operations for December 21, 22 and 23, 1941.

1. Your despatches 210617 and 210935 were received in garbled form from a Dutch station at about 2000 on December 21, but they could not be understood until they were again received over the Baker schedule from Corregidor at about 0030 December 22. At this time the Task Group was about seventy miles from Maworada Bay where it was expected to arrive shortly after daybreak.

2. In view of our position it was decided that the best chances for interception would be by proceeding to the north toward Makassar through Linda Strait, searching with aircraft. Two aircraft from this ship made contact with MARBLEHEAD at 1150 in Lat. 06-07, Long. 118-30, course 270, speed 10. The planes did not report contact by radio because of radio silence. At this time the HOUSTON was about ninety miles distant bearing 150 T. from the MARBLEHEAD, and could easily have effected a contact. While returning to the ship the planes mistook a small island they were passing over for another and in consequence missed the ship. They continued on to the southward and landed in Bima Bay. One plane reported their landing by radio without a call and using only the words "BT landing Bima". The ship then headed for Bima Bay to recover aircraft and did not learn of the location of the MARBLEHEAD until the planes were recovered about 1730 that afternoon. My despatch 220630 was sent by government radio from Bima before I had recovered aircraft. At that time I thought the TRINITY Group, referred to in your 210617, would contain TRINITY, PECOS, OTUS, GOLD STAR and two destroyers, which would probably be headed for Maworada Bay, and that the MARBLEHEAD Group would be headed individually for Surabaya.

3. After recovery of planes Task Group 5.3 proceeded to the north of Alas Strait, arriving there at daybreak, December 23rd, and as was anticipated, contact was made with TRINITY and destroyers PAUL JONES and BARKER. Despatches were delivered to these vessels as required by your 221145. Your 221820 was also delivered in paraphrased form. The TRINITY Group was then directed to proceed on duty assigned, and headed for Alas Strait.

4. Task Group 5.3 is now to the westward of Kangean Island, has made contact with MARBLEHEAD by planes, and expects to meet her at about 1400.

5. After contact, Task Group 5.3 will escort PECOS, OTS and GOLD STAR to Port Darwin at best available speed, passing through Alas Strait in the morning of December 24, and then heading to the south of Soemba Island, keeping as clear of steamer lanes as possible. It is expected that we will arrive at Port Darwin in about five or six days from today. The destroyers will be fueled enroute, probably this afternoon from PECOS.

6. Referring to your despatch 221145, we do not understand the term "ACEE", but it is my expectation that the Naval Observer at that place will be able to inform me what organization is meant.
